1. APPLICATION OF TARIFF

1.1. GENERAL

This Tariff applies to the furnishing of Insight Phone Service, defined herein, by Insight Phone of Indiana, LLC, d/b/a INSIGHT Phone (hereinafter referred to as the "Company") within the state of Indiana. Insight Phone Service is furnished for the use of end users in placing and/or receiving local telephone calls within a Local Calling Area, or in placing intrastate calls within the state of Indiana. Services, features, and functions will be provided where facilities, including but not limited to billing and technical capabilities, are available.

The provision of Insight Phone Service is subject to existing regulations and terms and conditions specified in this Tariff as well as in the Company's current Tariffs for intrastate, interstate and international Services, and may be revised, added to, or supplemented by superseding issues.

In addition to the regulations and charges herein, this Tariff is subject to specific regulations as may be prescribed by the Indiana Utility Regulatory Commission.

1.2. TARIFF REVISION SYMBOLS

Revisions to this Tariff are coded through the use of symbols. These symbols appear in the right hand margin of the page. The symbols and their meanings are as follows:

- (C) -Change in regulation
- (D) -Discontinued rate, regulation or text
- (I) -Increase in rate
- (N) -New rate, regulation or text
- (R) -Reduction in rate
- (T) -Change in text

1. APPLICATION OF TARIFF

1.3. DEFINITIONS

Business Service (Commercial)

Service is classified and charged for as Business Service where the use is primarily or substantially of a business, professional, institutional or occupational nature, or where a business directory listing is furnished.

Company

Whenever used in this Tariff, "Company" refers to Insight Phone of Indiana, LLC, d/b/a Insight Phone, unless otherwise specified.

Customer

The person or legal entity that subscribes to Service under this Tariff and is responsible for payment of charges for Services furnished to that Customer.

Customer Premises

The Customer premises is all space in the same building occupied by a Customer and all space occupied by the same Customer in different buildings on contiguous property.

Local Calling Area

The area in which a Customer of Insight Phone Service may complete calls without incurring long distance charges.

Local Serving Area

The area in which the Company has the capability to provide Insight Phone Service.
